

## The vaccine of madness?

Since the end of 2019, an epidemiological crisis has faced the death of more than 2 million people and, nationally, has resulted in the dismissal of more than 230 thousand people from their families. These, unfortunately, are just numbers in what is considered the biggest crisis of recent times.

In addition to the deaths and sequels left by this crisis experienced and, for now, with no prospect of being ended, we are going through something that was not expected, hysteria due to the arrival of the vaccine. Various vaccination strategies have been developed by several countries, some prioritizing frontline health professionals, others prioritizing those and populations at risk, but none prioritizing the general public. The latter is the one that prevails on our soil,

however, it is not being well executed as shown by the press. General public “skipping the queue” to receive the vaccine, rising anti-vaccine trends and political polarization are organic in this scenario of chaos.

In addition, the lack of control and attention on the part of the federal government in the face of the growing number of deaths throughout the national territory, helps to aggravate the population's despair over the vaccine, which until then was aimed at a specific public. Many researchers attribute this situation to the outdated educational role of our population, which has been exposed to evidence since the beginning of the pandemic, which has never stopped as in other countries the level of deaths caused by the disease COVID-19.

In addition, one must also understand the psychological factor, which due to scarcity, partly due to the vaccine manufacturing process and partly due to the poor administration of the government, arouses the need for survival, endorsed by fear in the face of the increase in cases already mentioned.

The deep understanding of the processes that make up the being is arduous, but not impossible. Thus, since the primacy of the pandemic, stricter control should have been adopted in the face of inspection by the government, as well as by a large part of the population to remain in isolation. However, given the current scenario in which we find ourselves, the priority of vaccines is understood by the general population. ■
